- Each of such Committees as mentioned above shall submit monthly reports of the status of matters to the undersigned by the end of the first week of the following month.
- Whenever required, the Chairman of the Committee shall co-ordinate with the Chairman(s) of other Committee(s), so that there is always a proper cohesion.
- 8. After the decision(s) of a Committee have been approved, consequential action, including issuance of all necessary communication(s)/Order(s) and follow-up, shall be undertaken by the Officer In-charge through the concerned Branch.
