The Nomination list of officers of DHJS holding Children's Court for attending the programme on 24th September, 2022 is enclosed as Annexure 'A'.


It is requested that such nominated Judicial Officers posted in your district may kindly be communicated about their nomination in the aforesaid programme through your good office.
