Respected Sir,

A Foundation Course for a batch of Thirty-One (31) newly recruited officers of DHJS and an Induction Course for One (01) newly recruited officer of DJS, as approved by the Hon'ble Judicial Education & Training Programme Committee, High Court of Delhi, is presently being conducted by the Delhi Judicial Academy.
