Therefore, it is once again impressed upon all the Judicial Officers dealing with bail matters listed in Bail Roster of Session Courts, West District to send back the bail applications to the Bail and Filing Section, West District latest by 2.30 p.m. after its hearing /disposal, so that directions issued, if any, be complied timely. Further, Hon'ble Courts are also advised to not call the ministerial staff of Bail and Filing Section, West District for collecting the bail applications after its hearing /disposal.

The above directions should be followed scrupulously.
