


OFFICE OF THE PRINCIPAL DISTRICT & SESSIONS JUDGE (HQs): TIS HAZARI COURTS DELHI

In terms of Office Memorandum bearing No.57/05/2021-P&PW(B), dated 03.03.2023 issued by the Additional Secretary to Government of India, Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioner's Welfare, Lok Nayak Bhawan, New Delhi, I am directed by Ld. Principal District & Sessions Judge (HQs), Delhi vide letter No. 63674/Admn.II/PF-JA&JJA/2023 dated 23.08.2023, the following Officials /Ex-Officials are hereby switch over to the Pension Scheme under the Central Civil Services (Pension), Rules 1972 (now 2021) in place of National Pension System (NPS), who were selected against the posts/vacancies which were advertised/notified for recruitment/appointment, prior to the date of notification for National Pension System i.e. 22.12.2003 on the basis of one-time option exercised by them with effect from the date of their appointment as Employees of this Establishment, as per Annexure 'A':-

The NPS Accounts of the officials shall be closed w.e.f. 31<sup>st</sup> December, 2023.

As per DoP&PW O.M. No. 57/05/2021-P&PW(B) dated 03.03.2023, the officials shall be required to subscribe to the General Provident Fund w.e.f. 01.01.2024. The account of corpus in their NPS account will be dealt according to the instructions contained in Para 8(i), 8(ii), 8(iii) of the said Office Memorandum.


