Regular functioning of the Courts at District Courts, Delhi has been suspended since 23.03.2020 vide orders of Hon'ble High Court of Delhi bearing Nos. 373/Estt./E1/DHC dated 23.03.2020, No. 159/RG/DHC/2020 dated 25.03.2020, No. R-77/RG/DHC/2020 dated 15.04.2020, No. R-159/RG/DHC/2020 dated 02.05.2020, No. R-235/RG/DHC/2020 dated 16.05.2020, R-305/RG/DHC/2020 dated 21.05.2020, No. R-1347/DHC/2020 dated 29.05.2020, No. 16/DHC/2020 dt. 13.06.2020, No. 22/DHC/2020 dt. 29.06.2020 and No. 24/DHC/2020 dt. 13.07.2020.

<u>Vide order of this court dated 21.03.2020, this case was</u> <u>fixed for PE on 26.05.2020</u>. However, vide order No. E1792-1876/DJ/RADC/2020 dated 22.05.2020 of Ld. District & Sessions Judge-cum-Special Judge (PC Act)(CBI), Rouse Avenue District Court, New Delhi, all the matters fixed for 26.05.2020 were adjourned enbloc to 24.06.2020. Subsequently, vide order No. E-3943-4029/DJ/RADC/2020 dated 13.06.2020 of Ld. District & Sessions Judge-cum-Special Judge (PC Act)(CBI), Rouse Avenue District Court, New Delhi, the matters fixed for 24.06.2020 were adjourned enbloc to 23.07.2020. Now vide order No. Power/Gaz./RADC/2020/E-6836-6919 dated 14.07.2020 of Ld. District & Sessions Judgecum-Special Judge (PC Act)(CBI), Rouse Avenue District Court, New Delhi, it has been ordered that all courts at Rouse Avenue District Court Complex shall take up urgent cases (except where evidence is to be recorded) through Video Conferencing mode and other cases fixed from 16.07.2020 to 31.07.2020 have been adjourned en-bloc for different dates. Cases fixed for 23.07.2020 have been adjourned en-bloc to 26.08.2020. Accordingly, the present matter stands adjourned to 26.08.2020 for PE.
