The nomination list of Judicial Officers for the aforesaid programme is enclosed as Annexure 'A'. The schedule of the programme shall be communicated to the participants in due course.


It is requested that the nominated Judicial Officers posted in your district may kindly be communicated about their nomination in the aforesaid programme through your good office.


