Hon'ble Sir/Madam,

This is in reference to wireless message received in this office on 08.09.2025 from the DCP DAP/NAV 3rd Bn, Delhi Police respectively wherein it is directed to produce all the inmates through VC in view of the complete work strike called by Delhi Bar Association at all district courts, who are going for physical court production on dated: 08.09.2025.

In this regard, it is to inform that as per record approx 130 prisoners are required to be produced before multiple Hon'ble courts in all the District Courts of Delhi on today i.e. 08.09.2025. However, due to un-availability of escort guards from DAP/NAV 3rd Bn, Delhi Police, it is not facilitate to produce the said prisoners physically before the Hon'ble courts.

Further, it is to inform that due to limited sources/systems for producing the prisoners before the Hon'ble courts, it is not possible to produce at least 130 prisoners Through VC before the Hon'ble courts on 08.09.2025. Besides this, it is also not possible to send all the custody warrants of prisoners before the Hon'ble courts due to paucity of time.

Therefore, this Hon'ble court is humbly requested to kindly look into the present matter and pass necessary directions to all the Hon'ble Courts of Delhi, to avoid any adverse order as well as to avoid any illegal detention of prisoners.
