In case any nominated officer(s) is / are transferred/ retired/ has proceeded on long leave before holding of the programme, the successor officer shall stand nominated in his/her place for the programme automatically.

The nominated Judicial Officers may kindly be advised not to list any judicial work on 22th November, 2025, so that litigants and lawyers are not inconvenienced. In case some judicial work has already been listed, it may be preponed or adjourned accordingly, to the extent possible.
