2. Ld. Judicial Officers willing to opt for these hardbound law journals must submit their written request/Option Form (printed overleaf) to the Ld. Officer In-charge, Library of their respective Court Complex, for onward transmission to the Library, Branch Tis Hazari Courts, latest by 20/07/2026.
3. It be noted that these hardbound journals will be available and delivered at the end of the calendar year. It is explicitly clarified that once an option is exercised, the concerned officer(s) shall not to decline or deny the acknowledgment of the journals upon delivery.
