Guidelines for allotment of lockers of newly renovated Ladies Bar Room, Karkardooma Courts

1. Application are invited for allotment of lockers. Three categories of applicants/lady advocates have been made as under:
 - (A) Applicants/lady advocates who are having 0-5 year experience of practice as an Advocate in Shahdara Bar Association (Regd.), Karkardooma Court.
 - (B) Applicants/lady advocates who are having above 5 years - 10 years experience of practice as an Advocate in Shahdara Bar Association (Regd.), Karkardooma Court.
 - (C) Applicants/lady advocates who are having above 10 years experience of practice as an Advocate in Shahdara Bar Association (Regd.), Karkardooma Court.

Lockers for each category shall be allotted as per seniority in particular category. Applicant will apply in only one category and will clearly mention the category in which she is applying.

2. Lockers will be allotted to applicants/lady advocates on 02 year basis and will be reviewed periodically.
3. Applicant/Lady Advocate must be member of Shahdara Bar Association (Regd.), Karkardooma Courts, Delhi.
4. Applicant/Lady Advocate should not have any Chamber/Locker allotted by the Shahdara Bar Association (Regd.) in Karkardooma Courts Complex. Further, in future, if a chamber/locker is allotted to her, allotment of locker allotted by this Committee will be cancelled.
5. Proper care of locker be taken by allottee.

Documents to be submitted with application form.

1. Certificate of Enrolment issued by Bar Council of Delhi.
2. Membership Certificate/Copy of I.D. Card issued from Shahdara Bar Association.
3. Experience Certificate issued from Shahdara Bar Association (Regd.), Karkardooma Court.
4. An affidavit from the applicants/lady advocates submitting that no chamber/locker has been allotted to her and in future, if any chamber/locker is allotted to her, she will intimate this Committee.
5. Applicant/Lady Advocate will have to submit at least 04 copy of order sheet from January -2025 till now of appearing in the courts situated at karkardooma Court Complex, Delhi.
