

Subject: Directions of certain District Courts to establish a mechanism to share information related to cash transactions with Income Tax Department – reg.

Sir,

This is with reference to the recent orders of various District courts within the administrative jurisdiction of hon'ble Delhi High Court asking the Income Tax Department to formulate a proper online mechanism to intimate the information regarding cash transactions. It may kindly be recalled that the Hon'ble Supreme Court, in its order dated 16.04.2025 in the case of *RBANMS Educational Institution vs. B. Gunashekar & Another* (Civil Appeal No. 5200 of 2025) has mandated that in any suit where a claim is made that ₹2,00,000/- or more has been paid in cash towards any transaction, the concerned court shall intimate the jurisdictional Income Tax Department to facilitate verification and appropriate action as per law.

- 2. In view of the above, it is conveyed for the information of the Hon'ble High Court and the district judiciary under its jurisdiction that the Director General of Income Tax (Investigation), Delhi is the nodal authority in Delhi for receiving any information regarding any possible tax evasion and undertaking of necessary verification.
- 3. Accordingly, the judicial authorities may send the requisite communications to the following official email ID for appropriate action:

4. A physical copy of such intimation, where considered necessary, may be directly forwarded to the following address:

- 5. I am therefore directed to request to kindly disseminate the above to the appropriate judicial forums under your jurisdiction for information. The Judicial officer(s) concerned be also requested to share the Permanent Account Number (PAN) of each such person whilst forwarding the matters to the Income Tax Department, New Delhi.
- 6. This issues with the approval of the Principal Chief Commissioner of Income Tax, Delhi.
