As part of the activities to mark the 75th year of the establishment of the Supreme Court of India, a National Conference of the District Judiciary is being organised by the Supreme Court of India on 31 August and 1 September 2024. The Conference will be inaugurated by Shri Narendra Modi, Hon'ble Prime Minister of India. Smt. Droupadi Murmu, Hon'ble President of India will deliver the valedictory address on 1st September, 2024. It may please be noted that the judicial officers must take their designated seats at the venue of the Conference by 8.30 a.m on both the days.
