**CIRCULAR**

Consequent upon the decision taken by the competent authority vide office circular No.10989-11189/Cir./P & T/Admn.II(HQs)/2025 dated 03.04.2025 to the effect that henceforth, all the orderlies, peons, chowkidars, farash and safai karamcharis will be required to submit a certificate on the 1<sup>st</sup> of June each year, confirming that they have been consistently adhered to the prescribed uniform, in order to receive the dress allowance.

As such all the common categories of Group C (erstwhile Group D) employees who are entitled for "Dress Allowance" are directed to submit a certificate (as Annexure "A") duly signed by their Ld. Presiding Officers/Office In-charge at the earliest, failing which no dress allowance shall be released by the Accounts Branch in the month of July, 2025.
