Notes:-

- 1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- 3. The Principal District & Sessions Judge, Central District shall withdraw sufficient number of cases from the existing courts of District Judge-01 to District Judge-14, Central District and shall assign the same to the newly constituted courts i.e. District Judge-15 and District Judge-16, Central District and shall ensure that after redistribution, all the courts shall have substantially equal work.
- 4. The Principal District & Sessions Judge, West District shall withdraw sufficient number of cases from the existing courts of District Judge-01 to District Judge-07, West District and shall assign the same to the newly constituted courts i.e. District Judge-08, District Judge-09 and District Judge-10, West District and shall ensure that after redistribution, all the courts shall have substantially equal work.
- The Principal District & Sessions Judge, Central District shall withdraw sufficient number of cases from the existing court of Judge(Family Court), Central District and



shall assign the same to the newly constituted court i.e. Judge (Family Court-02), Central District and shall ensure that after redistribution, both the courts shall have substantially equal work. In view of the creation of new court, the existing court of Judge (Family Court), Central District previously presided over by Mr. Murari Prasad Singh is re-designated as Family Court-01, Central.

- 6. The Principal District & Sessions Judge, New Delhi District shall withdraw sufficient number of cases from the existing court of Ms. Gomati Manocha, ASJ (POCSO)-01, New Delhi District and shall assign the same to the newly constituted courts i.e. ASJ (POCSO)-02 and ASJ (POCSO)-03, New Delhi District and shall ensure that after redistribution, all the courts shall have substantially equal work. These 2 newly created courts shall function from RACC and the court of ASJ (POCSO)-01, New Delhi District functioning from PHC shall also be shifted to RACC. However, all these three courts shall be under the administrative control and jurisdiction of New Delhi District.
- 7. The Principal District & Sessions Judge, Central District shall withdraw sufficient number of cases from the existing court of Mr. Neeraj Sharma, District Judge-04 (LAC), Central District and shall assign the same to the newly constituted court i.e. District Judge-14 (LAC), Central District and shall ensure that after redistribution, both the courts shall have substantially equal work.
- 8. In terms of directions of Hon'ble Supreme Court in WP(C) 900/2020, officers who have been posted as District Judge (Commercial Court) for the first time, shall undergo compulsory training as scheduled by the Delhi Judicial Academy prior to taking charge of their respective courts.
