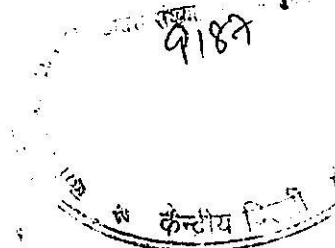

**ORDER**

Pursuant to the letter bearing no. 5954-5955/DHC/Gaz.IIB/G-7/2025 of the Hon'ble High Court of Delhi, it is hereby ordered to all the magistrate courts of this district that all the cases pertaining to the financial institutions and the telecom companies under section 138 of NI Act, 1881, wherein the total amount of cheque(s) in question is upto Rs. 50,000/- be transferred to the Evening Court no.-5 with immediate effect.

**Note:** Ahlmads and Assistant Ahlmads of all the magistrate courts are directed to identify the above said cases in the daily cause list and directly transfer those cases to Evening Court No. 5 one day in advance before the next date of hearing and get them allocated to Evening court through Computer Branch, South District and file the compliance report to the office of undersigned. List of transferred cases be also displayed separately on the notice boards of concerned magistrate courts alongwith daily cause lists.
