The nominated Judicial Officers may kindly be advised not to list any judicial work on 29th August, 2025 and 30th August, 2025 (as per their nomination) so that litigants and lawyers are not inconvenienced. In case some judicial work has already been listed, it may be preponed or adjourned accordingly, to the extent possible.
