



**TERMS AND CONDITIONS**

1. That condemned furniture articles shall be auctioned on 04.08.2025 at 03:00 P.M. on "AS IS WHERE IS BASIS" at B-Block Basement Parking and A-Block basement, Karkardooma Courts Comple, Delhi.
2. That reserved price of all condemned articles (excluding articles to be auctioned on the basis of their weight) is fixed Rs. 85,224/- (Rupees Eighty Five Thousand Two Hundred and Twenty Four only) plus taxes as applicable.
3. That bidder shall be required to deposit a sum of Rs. 10,000/- (Rupees Ten Thousand only) (Refundable) in cash alongwith a copy of Photo Identity Card with the Branch In-charge, Care Taking Branch before 01:00 P.M. on the day of Bid i.e. 04.08.2025.
4. The Successful bidder shall deposit 25% of the bid value on the acceptance of bid in cash as per rule 220(iv) of GFR-2017.
5. That the total auction price will be deposited by the qualified bidder within three working days (exluding bank holiday) in shape of demand draft drawn in favour of the Principal District & Sessions Judge (East), Karkardooma Court Complex, Delhi. In case of default, the deposit of 25% amount shall stand forfeited.
6. The condemned articles will be removed within three days after deposit of payments positively from the court premises.
7. That bidder shall arrange his own labour and transport for removal of condemned articles from Karkardooma Courts Complex, Delhi premises and expenses of such transportation shall be borne by him.
8. That decision of the Condemnation Board shall be binding upon bidder and it can cancel the auction without assigned any reason.
9. That condemnation board reserves right to add or delete any of terms and conditions at the time of auction proceedings and shall be binding upon all bidder/participants.




