- 1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district, to which they have been allocated.
- 2. The judicial officers under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- 3. The Principal District and Sessions Judge, West District shall withdraw sufficient number of cases from the existing court of JSCC-cum-ASCJ-cum-Guardian Judge, West District and assign the same to the newly constituted court of JSCC-cum-ASCJ-cum-Guardian Judge-02, West District for ensuring equal distribution of work. In view of the creation of new court, the existing court of JSCC-cum-ASCJcum-Guardian Judge being presided over by Ms.Neha Pandey is re-designated as JSCC-cum-ASCJ-cum-Guardian Judge -01.
- 4. The Principal District & Sessions Judge, Central District shall withdraw cases of PS Wazirabad from the court of JMFC-07, Central District and cases of PS Kamla Market from the court of JMFC-08, Central District and shall assign them to the

newly created court of JMFC-12, Central District to ensure equal distribution of work.

- 5. The Principal District & Sessions Judge, Central District shall withdraw cases of PS Roop Nagar from JMFC-05; cases of PS Jama Masjid from JMFC-01 and cases of PS Kashmere Gate Metro from JMFC-09 and shall assign them to the newly created court of JMFC-13, Central District to ensure equal distribution of work.
- The Principal District & Sessions Judge, West District shall withdraw cases of PS Mayapuri from JMFC-03, West District and PS Khayala from JMFC-04, West District and assign them to the newly created court of JMFC-09, West District to ensure equal distribution of work.
- The Principal District & Sessions Judge, West District shall withdraw cases of PS Nangloi from JMFC-05, West District and shall assign them to the newly created court of JMFC-10, West District.
- The Principal District & Sessions Judge, West District shall withdraw cases of PS Hari Nagar from the court of JMFC-06, West District and cases of PS Paschim Vihar East from the court of JMFC-07, West District and shall assign them to the newly created court of JMFC-11, West District.
- The Principal District & Sessions Judge, South-West District shall withdraw cases of PS Mohan Garden from the court of JMFC-02, South-West District and shall assign them to the newly created court of JMFC-12, South-West District.
- The Principal District & Sessions Judge, South-West District shall withdraw cases of PS Chhawla from the court of JMFC-07, South-West District and shall assign them to the newly created court of JMFC-13, South-West District for equal distribution of work.
- 11. The Principal District & Sessions Judge, South-West District shall withdraw sufficient number of cases from the existing courts of JMFC (Mahila Court) in South-West District and assign them to the newly created court of JMFC (Mahila Court)-06 for ensuring equal distribution of work.
- 12. The Principal District & Sessions Judge, West District shall withdraw sufficient number of cases from the existing courts of Civil Judge-01, Civil Judge-02 and Civil Judge-03, West District and assign them to the newly created court of Civil Judge-04, West District.
- 13. JMFC (NI Act) Digital Court-02, East, KKD previously presided over by Ms.Arushi Parwal; JMFC (NI Act) Digital Court-12, South-West, Dwarka previously presided over by Ms.Neelmani Sharma; JMFC (NI Act) Digital Court-01, North-West, Rohini previously presided over by Ms. Garima Garg and JMFC (NI Act) Digital Court-11, South-West, Dwarka previously presided over by Ms.Akanksha Singh are hereby

abolished. All the remaining 34 Digital (NI Act) Courts shall function from the Rouse Avenue Court Complex. However, these courts shall continue to be under the administrative control/supervision/jurisdiction of the concerned Districts to which these courts belong. The remaining arrangement, including support staff deployment and recording of evidence from the respective District Court Complexes, may continue as per the previous directions/practice until adequate and permanent space is made available in the concerned District Courts to which these Digital NI Act Courts ultimately belong. The Readers, Ahlmads, and Judicial Records of these Digital NI Act Courts would also continue to function from their original Districts so as to avoid any inconvenience to the litigants, lawyers, and stakeholders.

14. All Relieving JMFC/Civil Judges shall perform all judicial works except deciding the cases finally. However, if they are deputed in a court where the officer is on long leave i.e. beyond one month, in such cases, the Relieving JMFC/Civil Judge shall also be empowered to decide the cases finally. All learned Principal District and Sessions Judges shall keep record of the work done by the Relieving JMFC/Civil Judges posted in their respective districts and shall forward the same to the High Court on quarterly basis or till they get regular posting whichever is earlier.
