**SUB: INTIMATION REGARDING NON PRODUCTION OF THE UTP'S ON
DATED 08.09.2025**

Hon'ble Madam/Sir,

This is in reference to the wireless message received from DCP NAV/DAP 3rd Bn, Delhi Police wherein it is informed that in view of complete work strike called by Delhi Bar Associations at all district Courts for tomorrow i.e 08.09.2025, it is not feasible to produce UTP's physically.

In this regard, it is to inform that as per record, approx 156 prisoners were required to be produced before various Hon'ble District Courts of Delhi today i.e 08.09.2025. However, due to un-availability of escort gaurds from DAP/NAV 3rd Bn, Delhi Police it is not feasible to produce the said prisoner physically before the Hon'ble District Courts.

Further, it is to inform that due to limited sources/systems for producing the prisoners before the Hon'ble Court, it is not possible to produce 156 prisoners through VC before Hon'ble Courts on 08.09.2025. Besides this, it is also not possible to send all the custody warrants of prisoners before the Hon'ble Courts due to paucity of time.

Therefore, the Hon'ble Court is humbly requested to kindly look into the present matter and pass necessary directions to all the Hon'ble Courts of Delhi, to avoid any adverse order as well as to avoid any illegal detention of prisoners.
