Note 1. Every Presiding Officer of Evening Court (ECTC) shall be assisted by his/her own court staff consisting of Reader and one Orderly and the Presiding Officer of Evening Court (Regulars) except ECTC shall be assisted by his/her own Court staff consisting of Reader, One Stenographer/PA & One Orderly. In case the Reader of the Presiding Officer of Evening Court happens to be on leave, the Ahlmad/ Asstt. Ahlmad shall assist the Presiding Officer of Evening Court.

Note 2. It shall be the duty of the Orderly of the concerned Evening Court Judge to collect the Peshi one day in advance and shall return the files in the evening after the Court work is over to the concerned Ahlmad of the Evening Courts. In the absence of orderly, the Ahlmad of the concerned Evening Court shall do this work.

Note 3. It is impressed upon the Ld. Judicial Officer that they shall sign the fine statement on daily basis before leaving the Court premises.
