

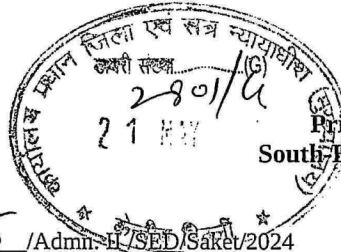

3. Non-compliance of the above directions or immediately proceeding on leave shall be viewed seriously and the official will be liable for suitable disciplinary action as per rules.


