



ORDER

In pursuance to the letter bearing Endst. No. 3991/DHC/Gaz.IIB/G-8/D.M./2025 dated 11.07.2025, received from Hon'ble High Court of Delhi, New Delhi, it is hereby ordered that Ld. Duty Judicial Magistrate First Class of the day (including holidays), New Delhi District, New Delhi shall also be authorized to work as Judicial Magistrate during the Monsoon/Budget Session of Parliament from 21.07.2025 to 12.08.2025 or till the end of session (whichever is later) for the trial and disposal of cases of demonstrators who may be arrested during the Budget Session of Parliament from 21.07.2025 to 12.08.2025 or till the end of session (whichever is later) in accordance with law. The said Ld. Duty Judicial Magistrate First Class may hold his/her court outside the Court Premises, after office hours to ensure the speedy disposal of cases.
