Sub: Regarding ascertaining pendency of appeals, if any, in respect of matured case files which are to undergo weeding out process in accordance with the directions contained in the Judgment dated 09.01.2017 of the Hon'ble High Court of Delhi.

Respected Sir,

It is respectfully submitted that weeding out / destruction of as many as 8982 matured judicial case files (As per list attached- Annexure 'A') of different Magisterial Courts / Police Stations / Mauzas (nine in number) under West District at Rohini Courts (jurisdiction of West District remained here from January 2006 to October 2008), is to be initiated by this Record Room. In compliance with the directions of the Hon'ble High Court of Delhi passed in Criminal Appeal No. 736/2008, titled as 'State Vs. Tarif Singh' as mentioned in the captioned subject, before carrying out weeding out/destruction of matured judicial record, certain exercise has to be performed with regard to ascertaining the pendency of appeal, if any, in respect of these matured consigned judicial cases/record.
