Nominations from all the Districts have been received by this Academy in response to the aforesaid letter.

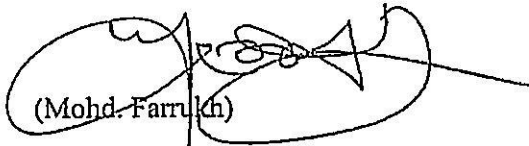
The final list of nominated Judicial Officers for the aforesaid programme is enclosed as Annexure-A.
